#### 2. Business from the Public

Stevens asked when the next chapters would be posted on GSA website. Stanin stated water budget chapter will be up with the next 2 weeks. Most chapters will be released early November. Stevens asked what the deadline for the comments. Stanin stated 30-day deadline for comments. Stanin advised all comments have been posted on the website.

#### 3. Approve 9/8/21 Meeting Minutes [Action item]

Tienken moved, 2<sup>nd</sup> by Ward, to approve 8/11/21 meeting minutes. Motion carried.

#### 4. Remote Teleconferencing Participation

Tienken moved, 2<sup>nd</sup> by Renfrow, to approve Remote Teleconferencing Participation resolution. Motion carried.

Ward asked if we must take action to teleconference every 30 days? Thorburn stated there should not be a problem meeting the 30-day window. Ward asked if we could meet in person and waive the AB 361 statute? Not yet.

#### 5. Degraded Water Quality

Renfrow moved, 2<sup>nd</sup> by Tienken, to approve Degraded Water Quality resolution. Motion carried.

- Henderson asked if the MCL is determined by the type of well that is being used? Stanin said ag irrigation wells are typically not used for monitoring wells unless they are already part of a monitoring network and the data is available from through a public database like GeoTracker.
- Stevens stated she doesn't remember a resolution on interconnected surface water. Enas stated it was presented in July's meeting.
- Reinhard asked if qualifiers will be attached to the minimum threshold exceedances since water levels tend to bounce around? Thorburn responded that it is difficult to include qualifiers in the definition for Undesirable Results. Stanin added that the relationship between undesirable results and minimum threshold exceedances is determined by its cause. If the exceedance range is defined too narrowly, the GSA might not be able to determine if the exceedance was caused by one of its projects.

#### 6. Budget and Schedule Update

Enas reported that Todd Groundwater has expended approximately 74% of budget and 92% of the time scheduled through August 31.

	Section 5. Effective Date of Resolution. This Resolution shall take effect immediately upon its adoption and shall be effective until the earlier of (i) November 28, 2021, or (ii) such time the Governing Body adopts a subsequent resolution in accordance with Government Code section 54953(e)(3) to extend the time during which the Governing Body of the GSA may continue to teleconference without compliance with paragraph (3) of subdivision (b) of section 54953.
Background and Discussion:	All meetings of the STRGBA GSA are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963) and related state laws and orders, so that any member of the public may attend either virtually or inperson as the case may be to participate and watch the GSA's governing body conduct GSA business.
	The Brown Act makes provisions for remote teleconferencing participation in meetings by members of a governing body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions, such as when a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558. It is further required that state or local officials have imposed or recommended measures to promote social

	distancing, or, the governing body meeting in person would present imminent risks to the health and safety of attendees.
	Such conditions now exist in the STRGBA GSA, specifically, a State of Emergency has been proclaimed pursuant to Government Code Section 8625 that the COVID-19 Pandemic has strained the State's healthcare system and workforce and that state and local health departments must use all available preventative measures to combat the spread of COVID-19. As a consequence of the declared emergency, the STRGBA GSA does hereby find that the governing body of the STRGBA GSA shall conduct their meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that such governing bodies shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953.

#### **RESOLUTION NO. 2021-10**

#### RESOLUTION CONFIRMING A CONTINUING STATE OF EMERGENCY ARISING FROM THE STATE OF CALIFORNIA AND STANISLAUS COUNTY ORDERS DUE TO THE COVID-19 PANDEMIC AND FURTHER AUTHORIZING REMOTE CONFERENCE MEETINGS OF THE STRGBA GSA'S GOVERNING BODY PURSUANT TO THE PROVISIONS OF THE BROWN ACT AND DULY ISSUED LAWS AND ORDERS FROM THE STATE RELATED TO THE PANDEMIC AND OPERATIONS FOR GOVERNING BODY MEETINGS.

WHEREAS, the STRGBA GSA is committed to preserving and nurturing public access and participation in meetings of its governing body; and

WHEREAS, all meetings of the STRGBA GSA are open and public, as required by the Ralph M. Brown Act (Cal. Gov. Code 54950 – 54963) and related state laws and orders, so that any member of the public may attend either virtually or in-person as the case may be to participate and watch the GSA's governing body conduct GSA business; and

WHEREAS, the Brown Act, Government Code section 54953(e), makes provisions for remote teleconferencing participation in meetings by members of a legislative body, without compliance with the requirements of Government Code section 54953(b)(3), subject to the existence of certain conditions; and

WHEREAS, a required condition is that a state of emergency is declared by the Governor pursuant to Government Code section 8625, proclaiming the existence of conditions of disaster or of extreme peril to the safety of persons and property within the state caused by conditions as described in Government Code section 8558; and

WHEREAS, a proclamation is made when there is an actual incident, threat of disaster, or extreme peril to the safety of persons and property within the jurisdictions that are within the GSA's boundaries, caused by natural, technological, or human-caused disasters; and

WHEREAS, it is further required that state or local officials have imposed or recommended measures to promote social distancing, or, the legislative body meeting in person would present imminent risks to the health and safety of attendees; and

WHEREAS, such conditions now exist in the GSA, specifically, a State of Emergency has been proclaimed pursuant to Government Code Section 8625 that the COVID-19 Pandemic has strained the State's healthcare system and workforce and that state and local health departments must use all available preventative measures to combat the spread of COVID-19; and

WHEREAS, since most restrictions from the State of California's Blueprint for a Safer Economy were lifted on June 15, 2021, the average daily case rate of COVID-19 in Stanislaus County has increased 9-fold and the testing positivity rate has risen 4-fold, though those conditions may change daily and weekly; and

WHEREAS, as a consequence of the declared emergency, the STRGBA GSA does hereby find that the governing body of the GSA shall conduct their meetings without compliance with paragraph (3) of subdivision (b) of Government Code section 54953, as authorized by subdivision (e) of section 54953, and that such legislative bodies shall comply with the requirements to provide the public with access to the meetings as prescribed in paragraph (2) of subdivision (e) of section 54953; and

WHEREAS, the GSA reserves the option to attend in-person meetings consistent with local health officer directives or to continue a practice of remote meetings that still allow multiple options for public participation.

NOW, THEREFORE, THE GOVERNING BODY OF THE STANISLAUS AND TUOLUMNE RIVERS GROUNDWATER BASIN ASSOCIATION GROUNDWATER SUSTAINABILITY AGENCY DOES HEREBY RESOLVE AS FOLLOWS,



#### 3. Approve 9/22/21 Minutes [Action item]

Renfrow moved, 2<sup>nd</sup> by Tienken, to approve 9/22/21 meeting minutes. Motion carried.

#### 4. Projects and Management Actions

Taghavi presented on Sustainable Management Criteria for Projects and Management Actions. The presentation can be accessed at the STRGBA GSA website: <u>www.strgba.org</u>.

- Henderson asked about the time frame for Non-District East pumpers to initiate these projects and who will determine the pricing structure? Thorburn responded that the project proponent is responsible for taking the lead, but we don't have an exact timeline. If monitoring data continues to show worsening conditions, the projects will have to start immediately. Stanin stated that Stanislaus County has been working with non-district east landowners and that some projects are already being implemented.
- Henderson asked how the GSA plans on monitoring the NDE pumping to ensure that growers are turning off pumps, and will the growers be required to furnish their pumping data?? Stanin said we are going to need additional wells and one of the management actions is to improve the monitoring network. The monitoring wells will help determine if water levels are recovering. Also, SGMA requires extraction data be included in the annual reports. So we will need to set up a program to do that accurately.
- Henderson asked if the cost of additional monitoring wells will be allocated solely to the NDE or will those costs be assessed basinwide? Thorburn stated the monitoring wells are currently managed by the GSA and we don't see significant costs increase. Also, we will be going after grant funding to help defray some costs.
- Henderson asked if those costs will be assessed on the member agencies and their constituents, and if so, will those discussion take place in public? Thorburn responded that those discussions haven't taken place yet, but it will be a public discussion.
- Reinhard asked about her comment letter on interconnected surface water. Are there any changes other than the response to the letter? Stanin stated they have not responded to the letter yet because some of the concerns will be addressed when the chapters are posted. Stanin also mentioned that the model results show substantial improvements over the baseline, with the aquifers maintain connectivity to the rivers. We still want to improve streamflow conditions even though we're not required to fix conditions that occurred prior to 2015.

- Stevens asked have the MID or OID Boards considered the amount of water available shown for in-lieu or direct recharge? Thorburn stated the numbers are from staff and represent the amount of water made available in years past. They haven't yet been approved by the Boards.
- Stevens asked if the lack of demand reduction in the GSP be a concern to DWR? Ward responded that demand reduction has been the subject of many discussions with NDE landowners.
- Stevens asked if specific management actions will be included if projects are not implemented? Stanin responded that management actions will be included as a backstop. If projects are not started right away we could see undesirable results occur immediately. Demand reduction will be included in the GSP and is needed since it will take time to implement projects. Ward agreed but added that January 31, 2022 deadline is the starting point and from that date forward we will begin implementation and learn how the GSP works.
- Mensinger mentioned that the MID Board has not made a decision on providing water for in-lieu and direct recharge projects to the NDE. He also added that the NDE growers have not organized into a groundwater replenishment district.
- Mensinger asked if using the past 50 years of hydrology is a good way to predict the next 50 years? Taghavi responded that DWR has looked into incorporating climate change into future modeling scenarios, but there is still much uncertainty on the impacts to future hydrology.
- Mensinger also added that the GSP should include projects in reserve since implementation takes time and the benefits won't be known immediately. He suggested including supplying more water to the City of Modesto as well as providing flood flows to lands within MID boundaries. Mensinger also mentioned that the Tuolumne River and Dry Creek flood mitigation projects need a better explanation for how those project will work. Ward responded that Stanislaus County should have a final report out on the Dry Creek project within 6 months. Mensinger added that the GSP should include many more alternative projects just in case some don't work out. We can't just cut off the supply of groundwater to growers.

# MANAGEMENT ACTIONS - FAQ

- They are not required to be implemented just because they are in the GSP
- The GSA will continue to evaluate options throughout implementation

### Management Actions described in the GSP are a framework

They will be fully developed if the GSA determines to implement them

## MANAGEMENT ACTION TYPES

- Demand Management Strategies Management actions developed to manage agricultural and urban water demands in the Subbasin. While conservation practices are already expected throughout GSP implementation, these strategies provide additional tools for the GSA to reach sustainability, if needed.
- Water Accounting Framework Management actions developed to help quantify and identify groundwater extraction volumes and locations, and/or develop systems to incentivize decreased groundwater extractions.

## Demand Management Strategies

### MAI – Voluntary Conservation and/or Land Fallowing

This action includes several strategies to achieve both temporary and permanent water demand reduction. Should the Modesto Subbasin GSA decide to implement this Management Action, it would assess options and develop a program to incentivize voluntary conservation and/or fallowing strategies in close coordination and collaboration with landowners.

### MA2 – Conservation Practices

This Management Action would create a program to support conservation practices in both urban and agricultural sectors. Urban water suppliers are already considering demand reduction and conservation efforts during dry periods, as outlined in Urban Water Management Plans (UWMPs). Larger agricultural water suppliers are also required to provide specific Efficient Water Management Practices in their Agricultural Water Management Plans (AWMPs), which MID and OID have both prepared.

# WATER ACCOUNTING FRAMEWORK

### MA3 – Groundwater Extraction Reporting Program

The GSP and future Annual Reports are required to provide quantified volumes for groundwater extraction,. This Management Action could pursue alternative volumetric groundwater extraction reporting data types or strategies. These could be activities such as voluntary reporting programs, or a more comprehensive program through satellite imagery and/or metering.

### MA4 – Groundwater Allocation and Pumping Management Program

This strategy involves development of a Groundwater Allocation Program for the Subbasin that would result in groundwater sustainability for the entire Subbasin.

### MA5 – Groundwater Extraction Fee

This strategy involves setting up a Groundwater Extraction Fee structure for each groundwater user. The fee structure could work in conjunction with the groundwater allocation and reporting programs, such that groundwater use above a certain allocation can be subject to a fee.

### MA6 – Groundwater Pumping Credit Market Trading Program

 Groundwater credit markets and trading programs can be used to exchange and trade the allocation of groundwater use by each landowner within the GSA.

# PLAN IMPLEMENTATION

- In addition to projects and management actions, implementation of the GSP includes:
  - Modesto Subbasin GSAs administration and management
  - Implementing and improving the monitoring program
  - Developing annual reports
  - Developing five-year GSP updates
- Implementation GSP Chapter also describes the contents the annual and fiveyear update reports
