5. GSP Cost Sharing Agreement

The Cost Sharing Agreement has been approved by all member agencies, except OID and City of Oakdale. Once signature page has been received from all agencies, Alvarez will distribute fully executed copy. Bushell mentioned DWR grant funding kickoff meeting will be held at Turlock Irrigation District (TID) on September 27, 2018. She invited the GSA member agencies to join for group meeting, group accepted.

6. Storm Water Resources Plan

Alvarez encouraged GSA members to participate in the Stanislaus Multi-Agency Regional Storm Water Resource Planning (SWRP) process. The SWRP intends to integrate relevant information and projects resulting from the Groundwater Sustainability Plan (GSP) developed for the Modesto Sub-basin into future SWRP efforts and projects, where feasible. The planning process will also study the possibility of using stormwater for groundwater recharge.

7. GSP Kickoff Meeting

Elliott gave a presentation on the GSP Work plan. Todd's first task will be to assemble existing groundwater data and develop a database. The data will be used to help develop the groundwater model. Elliot also requested groundwater production and elevation data from 1990 to present from each agency. She will forward a spreadsheet listing the required information. Deadline to submit data to Todd Groundwater is October 31, 2018.
