we will have a technical workshop on April 10th following the STRGBA GSA monthly meeting. This meeting will focus on the plan area. Stanin stated that the first two sections of the administrative draft are projected to be completed by the end of May. The Technical Advisory Committee will review and provide feedback.

5. Public Outreach Update

Wookey reported that the Stakeholder Assessment Survey (SAS) should be completed within the next 2 weeks. Alvarez suggested notifying the public of the SAS using bill inserts as well as posting a link to the survey to each agency's website. Davids asked the group to send Wookey any public email addresses that can be used in the future for outreach.

Enas reported that DWR's Facilitation Support Services (FSS) contract with Stantec has ended. The GSA has two options for facilitation support services moving forward. We can either to continue using Stantec under Todd's existing contract and budget or engage with the Center for Collaborative Policy (CCP) using DWR's existing FSS contract for facilitation support. Bushell stated DWR should have a new FSS contract inplace around September and the GSA can reapply then if Stantec is awarded the contract. Davids moved to continue using Stantec for now and follow up with DWR around September for additional support. 2nd by Riddell. Motion carried.
