## 4. Letter of Support for the West Turlock Subbasin GSA [ Action item]

Alvarez moved, 2<sup>nd</sup> by Thorburn, to approve letter of support to DWR on behalf of the West Turlock Subbasin GSA to be included with their application for Sustainable Groundwater Planning Grant Program funding – Round 3.

### 5. Communication Memo and Presentation

Pringle presented an overview of the process for implementing the stakeholder outreach plan. She also mentioned that Stantec would be providing a draft timeline for the stakeholder outreach effort at a subsequent meeting.

### 6. City of Modesto Grant Efforts

Alvarez informed the group that Woodard Curran is under contract with the City of Modesto to prepare the grant application. Since the grant application will include funding for monitoring well installation, STRGBA agencies will need to identify potential well locations. Alvarez stated the possibility of installing up to 17 wells with the grant funds, if approved.

### 7. GSP Update

Elliot reported on the progress of the GSP preparation. The C2VSim groundwater model had to be revised due to a problem with how the Corcoran clay was being modeled. Also, the Integrated Demand Calculator (IDC) was recalibrated using new data from the "unmanaged" areas.
